If any payment is not received within 90 days of the due date, the applicant hereby authorizes the Club to charge the amount due, plus any applicable fees or penalties, to the credit card listed on the account. A \$30.00 return fee will be charged for each returned bank draft or declined credit card (i.e. Revocations, Closed Accounts, & Non-Sufficient Funds).

Early termination will only be accepted in the event of a member who passes away or a member who has accepted a military assignment out of the area.

### **Terms and Conditions**

I agree to abide by all rules, regulations and bylaws of the Sly Fox Golf Club. I understand and agree that this membership will begin on the date that this Contract is signed and will run continuously until a cancellation form is filled out and submitted. I understand that this membership will automatically renew each year. ### **Cancellation**

Memberships may be cancelled by completing a Cancellation Form available at the Sly Fox golf club and will be honored under the following terms: The membership is for a one-year mandatory period and automatically renews for another one year period unless a Cancellation Form is completed and received. If a member chooses to cancel their contract before the end of the one-year membership period they will be subject to pay a \$500 early cancellation fee.
