_____ **Rental Option B: Must be a minimum of 4 Hours rental.** \$75.00 per hour plus \$25.00 Per hour staffing fee.

Banquet Room/Area Rental Agreement Includes tables and chairs

Deposit of \$50.00 is required to confirm the Date of your Event. You have up until 30 days prior to the event to cancel and receive a full refund. No refund within 30 days of the event will be allowed. Credit card number MUST be on file in case of any damages or breach of contract and will be billed if necessary.

Payment in Full is Due the Day of the Event.

Decorations: Renter agrees that decorations shall NOT be attached to the walls, existing wall decorations or woodwork, by use of nails, staples, etc. Special Arrangements may be made with permission of Sly Fox Golf Club Staff.

Alcoholic Beverages: Must be purchased from Sly Fox Golf Club. Absolutely NO outside alcohol is permitted on our property. Our ABC license strictly prohibits any alcohol on our premises other than what Sly Fox Bar & Grill can sell.

Food and Beverage: Renter may bring food or have it provided by an outside caterer. If you choose an outside caterer, they must bring certified documentation with them to cover any food illness that may occur while on our premises. Nonalcoholic beverages may be brought without any issue. Use of the Sly Fox kitchen facilities by the renter is prohibited, although kitchen assistance may be available by Sly Fox staff upon request.

Clean Up: Renter is responsible for general cleaning of the banquet room. This includes clearing of dishes, trash, cups with liquid dumped and removal of decorations on tables and on walls.

Rental area is expected to be left in the same condition at the end of the event that it was at the start of the event. Renter will be held responsible for any and all damages to the facility. Once again, the damages will be billed to the Credit card on file.

Liability and Security: Sly Fox Golf Club will NOT be held responsible for lost or stolen articles or merchandise left on the premises prior to, during or following an event.
